**Journal of Issues in Intercollegiate Athletics Editorial Review Board Announced**

MEMPHIS, TN--- August 8, 2007 – The College Sport Research Institute (CSRI) - sponsor of the *Journal of Issues in Intercollegiate Athletics* (JIIA) - announced members of the JIIA Editorial Review Board today.

Dr. Richard M. Southall, CSRI Director noted, “The response from faculty across the United States and overseas to the formation of CSRI and the *Journal of Issues in Intercollegiate Athletics* has been overwhelming. We are extremely grateful that so many well-respected scholars have agreed to serve on the JIIA Editorial Review Board (ERB). The members’ depth and breadth of knowledge related to intercollegiate athletic issues is very impressive. I’m sure the quality of the journal’s editorial review board will encourage faculty engaged in college-sport research to submit quality manuscripts to the journal.”

“JIIA editor, Dr. Kevin L. Burke, will be issuing a call for papers on or about September 1, 2007 and the ERB will begin the review process as manuscripts are submitted. JIIA will be published as an “online” journal with each year’s volume being updated as articles are accepted. We expect to have the first articles published late in 2007 or early in 2008.”

Southall commented, “Everyone associated with CSRI is excited about the journal’s potential to support the dissemination of quality, independent research about issues in college sport. We feel the online format will also allow for dissemination of the journal’s articles to a wider audience. We hope JIIA can be a journal that’s read by both college-sport researchers and college-athletic administrators.”
