### **ELIGIBILITY FOR GYM AND POOL PRIVILEGES**

In order to use Department of Exercise and Sport Science facilities, and be eligible to participate in all Campus Recreation programs, University of North Carolina at Chapel Hill (UNC-CH) faculty/staff and/or each member of their immediate families and UNC Hospital employees (spouses and children not eligible) must pay a fee. *Payroll deduction is encouraged for convenience in renewal.*

#### **Current Fee Schedule**

##### **Annual Payment for Privileges (August 1-July 31)**

Adult - \$120.00

Child - \$24.00 (pool privileges only)

##### **Prorated after January 1<sup>st</sup>**

Adult - \$60.00

Child - \$20.00 (pool privileges only)

##### **Prorated after Commencement**

Adult - \$30.00

Child - \$15.00 (pool privileges only)

- Dependent children (age 18 or younger) of UNC-CH faculty/staff and dependent children of UNC-CH current students who have purchased a Privilege Card are **ONLY** eligible to use the pools, and only during specified recreational swim hours for children. Children of faculty/staff aged 19 or older are not eligible to purchase pool privileges. Children are **NOT** permitted in any other recreational facility at any time.
- An adult must accompany children under 12 years of age when using the pools.
- Spouse and dependent privileges require an additional one-time \$5.00 charge to cover the costs of preparing a picture ID card.
- The term “dependent children” refers to children 18 years of age and under, residing at home with the eligible parent or guardian.

### **STEPS TO ACQUIRING GYM & POOL PRIVILEGES**

1. Verify eligibility.
2. Present payment and proper documentation at the UNC One Card Office, which is located on the ground floor of Daniels Building (UNC Student Stores) on South Road, directly across from the Student Recreation Center. Hours: 7:30am – 5:00pm, Monday-Friday. Phone: 919-962-1385.

## ELIGIBLE USERS

- **UNC-CH Faculty/Staff** must be a member of TIAA or the State Retirement System and may purchase privileges for themselves and/or their spouse, partner and dependent children. Policy includes General Administration and UNC Press employees. The UNC-CH Faculty/Staff member must purchase the privilege in person with proper identification and retirement number. *Payroll deduction is only available to PERMANENT full- or part-time employees of UNC-CH.*
- **UNC Hospital Employees and House Staff** must be **PERMANENT** full- or part-time (20 hours or more a week) and may purchase the privilege for themselves with a completed “Verification of Employee Status” form. This form is obtained from the Employee Recreation Office, 9<sup>th</sup> Floor, Main Hospital. UNC Hospital employees are not eligible for payroll deduction. Spouses and dependants of UNC Hospital employees are not eligible to receive privileges.
- **Post Doctoral Fellows** may purchase the privilege for themselves and/or their spouse and dependent children age 18 and under (must be residing in home). The post doctoral fellow, spouse, and/or dependent must purchase the privilege in person with proper identification at the UNC One Card office.
- **Retired UNC-CH Faculty/Staff** (residing in Chapel Hill) may purchase the privilege for themselves and/or their spouse and dependent children. Please call the Benefits Department at 962-3071 to obtain verification form for EPA Faculty and EPA Non-Faculty employees. To obtain verification form for retired SPA employees, please call Employee Records at 962-2894.
- **Full-time UNC-CH Students** who are currently registered, paying student fees, and have a valid UNC One Card may use the facilities free of charge. UNC-CH students must have a valid UNC One Card and paid-in-full student account to purchase the privilege for their spouse or dependent children age 18 and under (must be residing in home).
- A full-time student who registers for fall classes but is not enrolled during the summer may purchase a **Summer Privilege** card at the One Card Office for \$30.00.
- **Visiting Scholars** may purchase the privilege for themselves and/or their spouse and dependent children age 18 and under (must be residing in home). The sponsoring department must first make application to the Benefits Section of Human Resources (complete Visiting Scholars forms) and then have the visitor acquire a UNC One Card at the One Card Office.
- **Continuing Studies Students** are eligible as long as they are enrolled in class. Privileges may be purchased at the One Card Office for \$60.00 per semester

## NON ELIGIBLE USERS

- **Alumni** are not eligible to purchase privileges unless they qualify in an “Eligible” category.
- **Tar Heel Temps** are not eligible unless they qualify in an “Eligible” category. Only permanent employees (20 hours or more per week) who are full-time members of TIAA or the State Retirement System are eligible.
- **Temporary Employees** are not eligible unless they qualify in an “Eligible” category. Only permanent employees (20 hours or more per week) who are full-time members of TIAA or the State Retirement System are eligible.
