Thus, there are those for whom labor is the lynchpin of gender, and those for whom it is sexuality. In this seminar, we will discuss these competing theoretical orientations and others, as well as cover some empirical patterns and trends. The emphasis will be on theory and research findings, with discussion of research methods as needed. Beyond theory, we will focus on work, family and labor market issues, and gender intersections. Most material will be about the United States, with a case study of China and some comparative readings.

Seminar participation will include weekly discussion, and occasional critiques of the readings to the group. Each student will write three short papers, no more than 7 pages each, and due at the end of February, March and April. The first will be on theory, the second a substantive problem, and the third on research design or methods. These may be part of a cumulative project, or separate essays drawing from the readings. Students working on ongoing projects should discuss with me how they can be integrated into the seminar requirements. We will discuss paper topics as we go.
